General conditions for the statement validity

The Manufacturer is admitted to ATS at the following conditions:

1. The Manufacturer has implemented a Quality System according to a national or international standard approved by an accredited certification body or recognised by RINA.
2. For any single Purchaser's Order, the Manufacturer is to make an application to the competent RINA Marine Office using RINA form and indicating "*Firm provided with RINA Alternative Testing Scheme (statement reference number)*".
3. The products are to be produced, inspected and tested in compliance with the Quality Control Plans (Q.C.P.) "NORMALIZED ITEMS" No. 3 dated 22/10/2020 and "QUENCHED AND TEMPERED ITEMS" No.3 dated 10/10/2023 approved by RINA. The name of the personnel appointed by the Manufacturer as responsible for any phase of the production and control process is to be clearly stated on relevant Q.C.P.
4. In addition to the Manufacturer's standard quality control, all testing activities and inspections to be carried out and all documents to be reviewed by the Manufacturer are to be included in the Q.C.P. approved by RINA.
5. Since this ATS covers only a part of the testing required by RINA Rules, the Q.C.P. is to identify the inspections and tests to be carried out in the presence of the RINA Surveyor, including the final test.
6. The Manufacturer is to agree with RINA the dates of execution of inspections and tests to be witnessed by RINA Surveyor, as required by the approved Q.C.P.
7. When required by RINA, products are to be manufactured in accordance with Type Approval Certificates and/or drawings approved by RINA.
8. Remarks on approved drawings, if any, are to be dealt with as the following:
 - 8.1 For Type A remarks written answer is to be submitted to RINA Plan Approval Centre. The competent RINA Marine Office is to be provided with copy of the correspondence and acceptance by RINA Plan Approval Centre.
 - 8.2 All other remarks are to be dealt with by the Manufacturer and/or the Surveyor in charge for final

testing.

9. On completion of the inspection and tests delegated to the Manufacturer as required by the relevant Q.C.P., the Manufacturer is to issue the following documents:

9.1 Manufacturer's relevant inspection and test reports signed by the appointed personnel and all the other required technical documents relevant to the testing.

9.2 Evidence that the remarks on the approved drawings have been dealt with, as applicable.

10. The final tests and inspections are carried out by the RINA Surveyor.

11. Upon the positive outcome of the final testing, the RINA Surveyor makes the product duly marked with the RINA stamp and issue the final Test Certificate.

12. Any "non conformity notice" or "client / shipyard claim" is to be forwarded to the competent RINA Marine Office with relevant "corrective actions" taken as soon as possible.

13. The validity of the present Statement is subjected to the satisfactory result of the intermediate audits and the Manufacturer premises, carried out according to the table included in this attachment. RINA reserves all the rights to perform unscheduled audits.

14. Any modification to the initial conditions (e.g. relevant to design characteristics of the product, production and control procedures, suppliers of main components) are to be promptly communicated to RINA, which reserves the right to require additional assessments.

15. In any case, RINA Surveyors are to be allowed to witness during the performance of production and control activities, upon their request.

16. RINA may suspend or withdraw the admission to the Alternative Testing Scheme in the case of modifications to requirements or conditions for initial admission.
